# U8 Ice World Hockey Program

The ICE WORLD U8 HOCKEY PROGRAM has been developed to serve the needs of players from age 4-8. The program is designed for players that have graduated from hockey basics and will reinforce the fundamental and advanced aspects of skating, shooting, passing, and stick handling, within the ADM setting. More advanced players will be challenged with the finer points of these skills. The program will adhere to the long term development model of sports development through its use of skills set groups and teams.

This five month program will incorporate 3 Ice slots each week for all players. It will support both half-ice and cross-ice players with skills set and proper ice utilization. The program is designed to work hand in hand with the Harford North Stars Ice Hockey Club's Half-Ice Mite Program.

Coaches in the program will be USA Hockey Qualified and work as a team to best benefit the U8 players at all levels and skills. All coaches in the program are focused on player development within a fun environment. The goal of all coaches is to create better skilled players that love to play the game of ice hockey through small area games, and stations.

The U8 Program provides 3 ice sessions a week to increase player development. Mondays evenings are designed to be skills sessions. The programs Wednesday night sessions are more focused on team and game skills. Sunday session is a game session where positional and skills concepts are focused upon.
